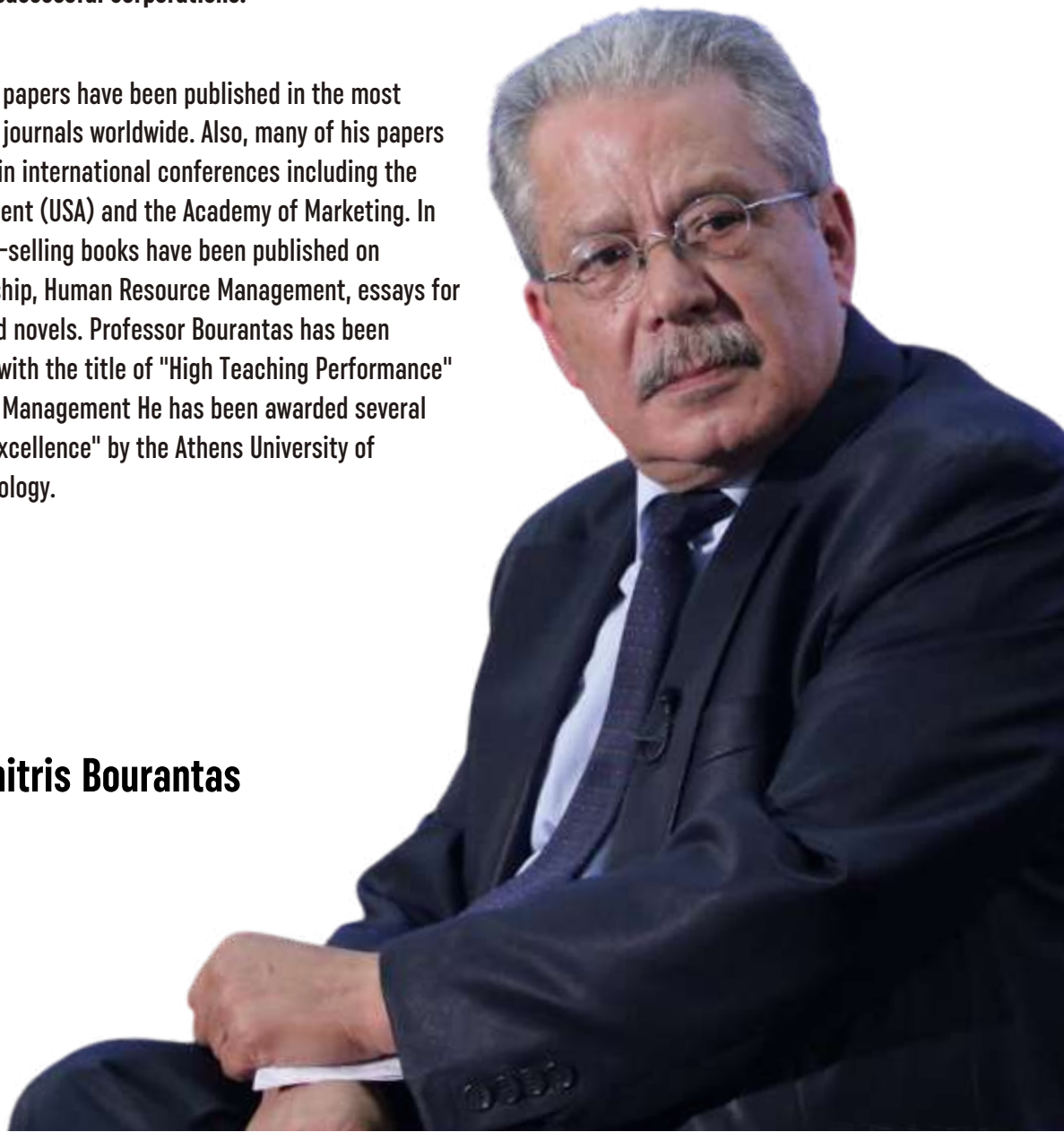

# MSc in Crisis Management in the Health Sector

The MSc Crisis Management in the Health Sector programme, designed in cooperation with the Hellenic Association of Crisis Management (HACM) provides a solid grounding in the major issues of crisis and security in the health sector in today's complex and globalised world. The combination of theory, practical insights and analytical skills prepares you for work in public or private organisations. The programme gives particular emphasis on the development of managerial, leadership and other soft skills.

The taught modules offer a rigorous training on a wide range of thematic areas such as strategic management of crisis and disaster, management of public health emergencies, armed conflicts and terrorism, health crises in schools, pharmaceutical industries and the tourism sectors, communication crisis management. Students have unique opportunities to enhance their practical skills through various exercises (simulations of crisis scenarios on cases such as public health emergencies, pandemics, terrorist attacks and mass casualties) which take place within each module.

# Bachelor in Business Administration

New York College offers a Bachelor's in Business Administration in collaboration with the School of Economic and Social Administration of the University of Toulouse 1 Capitole (UT1). This is a modern 3-year programme for students who wish to acquire the necessary knowledge and skills required for a successful career in business and management. Taught courses cover a wide range of subjects, such as economic theory, management, marketing, IT, law, European and international institutions.

Taught materials include case studies and practical examples, whereas by the end of each academic year students participate in the serious games – organized under the auspices of Faculty Members of UT1 – where they have a unique opportunity to enhance their business and soft skills by starting and developing a virtual enterprise. Note: Except for the business games and the English courses (e.g. Business English), the programme is offered in the Greek Language.

# M1 in International Economic Law

NYC is offering a Master's degree (M1) in International Economic Law in collaboration with the University of Toulouse 1 Capitole. The degree will be offered entirely at New York College in Greece, whereas the courses will be taught by distinguished scholars with strong academic and professional experience, including faculty members from the Law School of the University of Toulouse.

The Master 1 in International Economic Law provides a solid base of knowledge and skills in order to compete in the modern work environment setting, in positions related to international and European economic law. Graduates of the programme may find a placement in Law Firms, as well as in private and public Institutions and Organisations. They may also continue their postgraduate studies by applying for the Master 2 in International Economic Law.

In 2020, New York College offered for the first time a Master's Degree in International Economic Law (M2 in International Economic Law) in collaboration with the University of Toulouse. Enrolled students had a unique opportunity to study locally and receive the degree of one of the most prestigious law schools in Europe. The courses were taught by Greek scholars, Professors from the Law School of the University of Toulouse, as well as by several distinguished guest speakers, such as Dr. John Fellas, a world-class arbitrator and Adjunct Professor at New York University (NYC).

Students will receive intensive training on a wide range of subjects related to the EU law, competition law, international trade, intellectual property, media, business law, arbitration, international law, tax law, property protection, human rights. The acquired skills will enable them to start or further enhance their career potentials as professionals in public and private enterprises, as well as in international organizations.

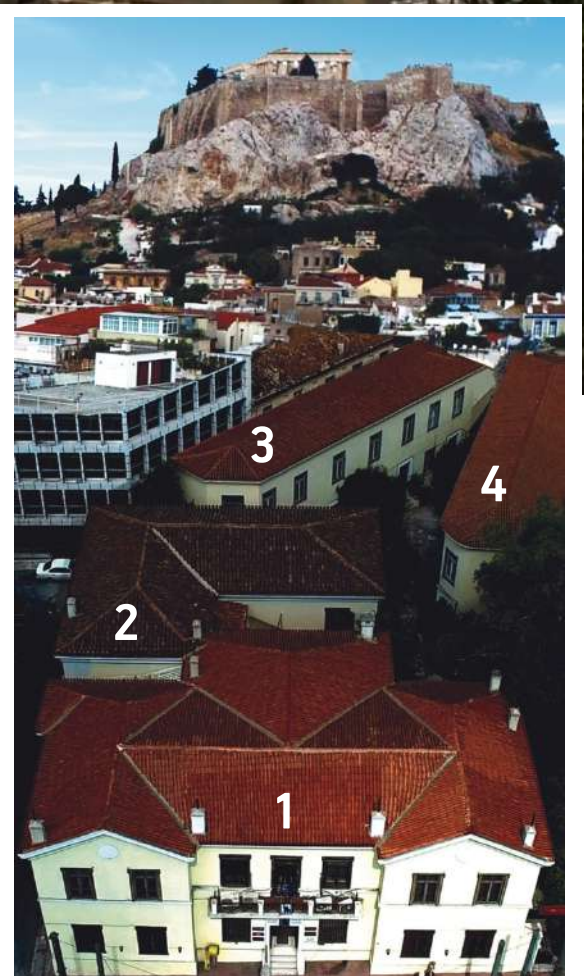


## NYC ATHENS CAMPUS

### Dionysia – Theodora Avgerinopoulou

Dr. Dionysia-Theodora Avgerinopoulou is a Member of the Hellenic Parliament and Chair of the Environment Committee of the Parliament. She has served as the Vice-Chair of the Global Water Partnership Organization in Stockholm, Sweden, and the Chair of the Energy and Environment Commission of the ICC Hellas. She is also the Executive Director of the European Institute of Law, Science & Technology. She is an expert attorney in Environmental Law and Policy, European Law and International Law and runs her own law offices in Athens, Greece. Previously, Dionysia also served as the Chair of the Special Permanent Parliamentary Committee on Environmental Protection of the Hellenic Parliament and the Subcommittee of the Watercourse, as well as the Chair of the Mediterranean Parliamentarians for Sustainable Development. She was also elected three times as a Member of the Parliament in Greece. Dr. Avgerinopoulou has been presented with the Green Star Award by the UNEP/OCHA/Green Cross International, and she has been elected as a Young Global Leader of the World Economic Forum and one of the 40Under40 Young European Leaders. She holds a J.S.D. (Ph.D.) in International Environmental Law from Columbia University School of Law and an LL.M. in International Legal Studies from Georgetown Law Center. She is an international lawyer and the Director of the European Institute of Law, Science & Technology. Dr. Avgerinopoulou is the Programme Leader of the Master (M2) in International Economic Law which is offered at New York College in collaboration with the Université Toulouse 1 Capitole.

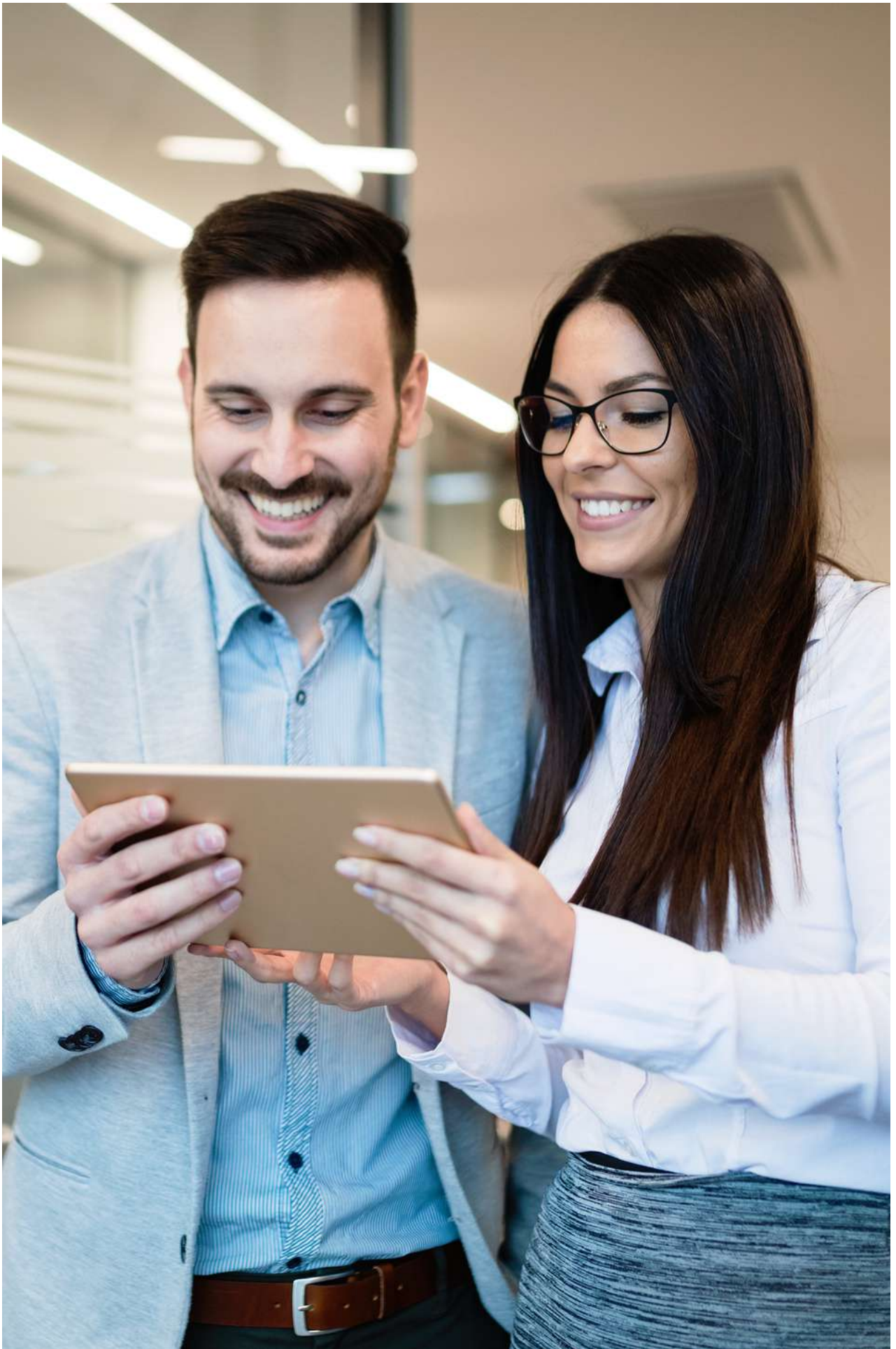
